Special Event Regulations/Requirements:

- Submit site plan. Required information: Property lines, locations of all buildings, locations of all tents, fire lanes, entrances/exits, areas for cooking, stages, location of restrooms, location of power sources, location of any temporary signs and decorations (inflatable), any open flame or pyrotechnics, and any other temporary use of materials that would not normally be present on site.
- Submit completed permit application -- minimum 30 days prior to event.
- Submit floor plan. Required information: Area of congregation of people, tables/chairs, exit ways, extinguisher locations, lighting procedure for power outages, location of electrical equipment, any special materials for display or use and seating capacity (posted signage).
- Submit tent information. Required information: Approved material used for tent, all open flames (minimum 20 feet from tent), 3 foot corridor between contents of tent and tent envelope, minimum 1-4A or 2-2A fire extinguishers for each tent. Hay straw, shavings or similar materials in or around tents are prohibited.
- Submit application for other fire related permits. Permits required for open burning (EPA and Local Fire), tent permit and air supported structure (local Fire), place of assembly permit, firework permit, pyrotechnics and special effects permit.

- ✓ Other Requirements
 - ✓ Banners, flags, or other temporary advertisements are prohibited on the exterior of any building or in front yards/setbacks.
 - ✓ Temporary signs / inflatable Permits Required.
 - ✓ Noise ordinances are in effect for Special Events.
 - ✓ Other requirements may be enforced upon inspection.
